B. ADDITIONAL COMMENTS TO SUPPORT JD:

Description

Part of this area was delineated in 2007 and an approved JD was issued for that portion on February 27, 2008 (SPK-2007-1819) that determined there were no wetlands within that portion. Based on aerial and digital photographs submitted by the applicant, it appears that there have not been any changes to that area covered in the delineation. In the 2007 delineation the consultant documented that the area was hydrologically severed from its main water source, a flood irrigated pasture, when Park Lane was constructed. The May 2012 delineation indicates that this is likely the case as there were no wetlands within the review area. Some datapoints did present hydrophytic vegetation, however, there were no hydrologic or soil indicators.




Figure 1. USGS map showing the Project Area.
