The reservoir is sustained by Boulder Spring, which is at the southwest corner of the reservoir, and drains into Boulder Creek, an intermittent stream, which flows through a wetland complex and into Boulder Lake, an intrastate terminal lake. Boulder Reservoir does not have a connection to a TNW.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity

of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Boulder Reservoir is a 6-acre impoundment. The reservoir is sustained by Boulder Spring, which is at the southwest corner of the reservoir, and drains into Boulder Creek, an intermittent stream, which flows through a wetland complex and into Boulder Lake, a terminal intrastate lake. These waters are located within the Massacre Watershed, where they flow north, toward Boulder Lake. Other waters within the watershed flow south into the Wall Canyon Watershed. Several ephemeral drainages flow south from Boulder Creek, but terminate at springs or before reaching another water. One aqueduct flows from Boulder Creek and terminates at Horse Canyon Springs, approximately 3 miles to the south.

Boulder Reservoir's primary uses are wildlife habitat, stock water, fishing, and recreation. Both Boulder Reservoir and Boulder Lake were assessed for their potential to qualify as TNWs; however, neither of these waters can be connected to interstate or foreign commerce. Searches were conducted through the Corps' database, as well as through the internet, and though both waters are used for fishing and recreation, no documentation can be found that connects them to interstate or foreign commerce. Boulder Reservoir is an intrastate, isolated water with no connection to a TNW.
