Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **Two man-made stormwater detention basins (1.14 acres) and two seasonal wetlands (1.03 acres) were identified within the review area. The basins receive storm water from the adjacent industrial facility, formerly the Riverbank Army Ammunition Plant. A lift station located to the west of the basins pumps water from underground pipes into the western basin (#1), which overflows into the eastern basin (#2). Water generally evaporates from the basins. Pipes are installed on the northwest bank of each basin conveying overflow water to a discharge box northwest of the basins. Water coming from this box feeds wetland W2.**

Wetland W2 is approximately 0.89 acre and starts at the basin discharge, continuing north in a linear shape along Claus Road toward the northwest corner of the property. The wetland terminates prior to the northwest corner and no inlets or outlets from the property were observed. An active railroad track servicing the industrial facility enters the property immediately north of the wetland and separates this portion of the property from the northwest corner. Aerial photography indicates that flood irrigated property to the north drains toward this corner and may be connected to a drain located in the vicinity. The wetland does not appear to connect to other features and the railroad tracks separate the wetland from the corner of the property near the potential drain on the north property. No tributary or other water conveyance is known near wetland W2.

Wetland W1 is approximately 0.14 acre and is located at the northeast corner of the property on the north side of the railroad. A standpipe is located along the fence line on the neighboring property to the north. The standpipe appears to be part of the flood irrigation system on the north property. Water from the standpipe backs up and spills into the review area creating wetland W1 on the property. This feature does not flow back to the north or flow toward any of portion of the property. There are no known connections to tributaries or other water conveyances near wetland W1.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

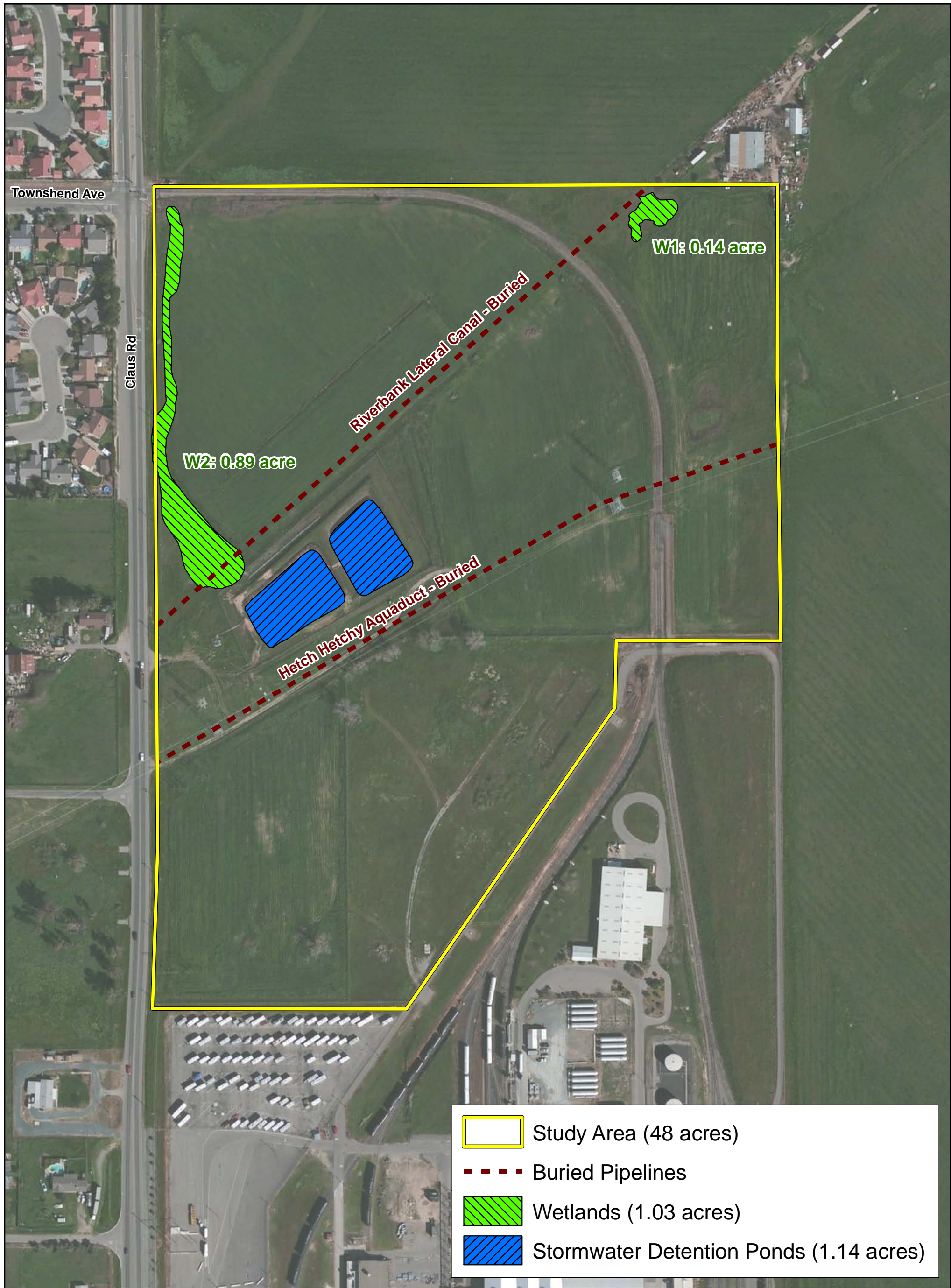
**Two man-made stormwater detention basins (1.14 acres) and two seasonal wetlands (1.03 acres) were identified within the review area. The basins receive storm water from the adjacent industrial facility, formerly the Riverbank Army Ammunition Plant. A lift station located to the west of the basins pumps water from underground pipes into the western basin (#1), which overflows into the eastern basin (#2). Water generally evaporates from the basins. Pipes are installed on the northwest bank of each basin conveying overflow water to a discharge box northwest of the basins. Water coming from this box feeds wetland W2.**

Wetland W2 is approximately 0.89 acre and starts at the basin discharge, continuing north in a linear shape along Claus Road toward the northwest corner of the property. The wetland terminates prior to the northwest corner and no inlets or outlets from the property were observed. An active railroad track servicing the industrial facility enters the property immediately north of the wetland and separates this portion of the property from the northwest corner. Aerial photography indicates that flood irrigated property to the north drains toward this corner and may be connected to a drain located in the vicinity. The wetland does not appear to connect to other features and the railroad tracks separate the wetland from the corner of the property near the potential drain on the north property. No tributary or other water conveyance is known near wetland W2.

Wetland W1 is approximately 0.14 acre and is located at the northeast corner of the property on the north side of the railroad. A standpipe is located along the fence line on the neighboring property to the north. The standpipe appears to be part of the flood irrigation system on the north property. Water from the standpipe backs up and spills into the review area creating wetland W1 on the property. This feature does not flow back to the north or flow toward any of portion of the property. There are no known connections to tributaries or other water conveyances near wetland W1.

Two additional potential wetlands were delineated in the original July 2012 report. A potential feature located adjacent to wetland W1 did not meet the wetland parameters and was removed from the map. A second potential feature was identified along the eastern boundary of the site. The feature received hydrology from the adjacent property to the east that flowed into the review area. The access road on the adjacent property was raised in order to prevent water from exiting the site. With the removal of water from the neighboring site, the feature no longer meets wetland parameters. The applicant revised the map to remove these features, but the original delineation report was not modified.

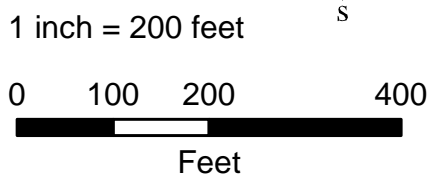




- Study Area (48 acres)
