2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": The wetlands within the study area are part of a larger wetland complex that is adjacent and abutting the Great Salt Lake. The 3.53 acres of wetlands covered in this datasheet are located at the same approximate elevation as the native wetlands. This area has a naturally high water table which provides sufficient hydrology during the growing season. These wetlands are similar in vegetation and hydrology to other wetlands in the area. Although historically it appears that this was one large wetland area connected to the Great Salt Lake, there have since been human impacts that segmented the large wetland into smaller wetland areas, including I-80, several slag piles, roads and berms constructed to contain water contaminated from historic mining activities in the area. However, these wetlands meet the definition of wetlands adjacent to a TNW, according to the definition of adjacency which is defined in 33 CFR 328.3(c) as "bordering, contiguous, or neighboring". These wetlands, although approximately 1 mile from the Great Salt Lake, are part of the larger wetland complex adjacent to the Lake south of I-80. In addition, the north end of the wetland is connected to a drainage ditch that flows north under the railroad and eventually under I-80, draining into the Great Salt Lake.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
