project area, Spring Creek has been piped and routed into the city storm drain system. The nearest jurisdictional water is a detention basin on Spring Creek, approximately 115 feet upslope to the east and is separated from the study area by 400 East. The detention basin discharges into the city storm drain system and does not flow under the road into the study area wetland. The wetland is in a depressional area entirely surrounded by uplands. There are no outfalls or channels flowing into the study area. Small seep areas and ground water contribute to the hydrology in the segment of abandoned stream channel where the wetland occurs. No associated interstate or foreign commerce was identified. The nearest TNW is Utah Lake, approximately 2.8 miles to the west. The Corps has determined that the wetland within the study area has no potential for significant nexus to jurisdictional waters and is being evaluated as an isolated wetland feature.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
