Explain: **The features identified as Wetlands B, C, E and F were evaluated as potential wetlands but these features did not meet wetland parameters. Several years ago, the hydrology source that may have contributed to these features was a culvert from under I-15 to the east that flowed into**

Wetland B. As part of the recent I-15 reconstruction project in this area, that drainage was re-routed and piped into the channel to the north and no longer contributes any hydrology to these features. Therefore, Wetlands B, C, E and F no longer meet the hydrology or hydric soil parameters. These features are being evaluated as uplands.

Wetland D is supported by seeps on the eastern edges of the wetland. Flow from the seeps is confined to this wetland and does not continue through the existing culvert to the west. This culvert is 2-3 feet higher than the wetland ground level and no indication of flow conveyance was observed by Corps personnel during the June 26, 2014 site visit. If flow reached the culvert height, it would flow toward Wetland F, another depressional area. The concrete ditch connected to the western side of Wetland F is 1-2 feet higher than ground level. In the extremely unlikely event that flow reached the concrete ditch from Wetland F, it would continue through the channel for a short distance until it reached the areas where the ditch has been filled and/or obliterated. Beyond this point, there is no potential to convey flows and no potential connection to other channels or storm drains. This concrete ditch has not been in use for many years and no signs of flow was observed by Corps personnel. Therefore, the Corps has determined that Wetland D has no potential for significant nexus to jurisdictional waters and is being evaluated as an isolated wetland feature. The nearest TNW is Utah Lake, approximately 1.9 miles to the west.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
