During the initial field investigation on May 7, 2013, no hydrology was observed and soil saturation was not observed until a depth of 25 inches. The wetland vegetation is briefly and sporadically supported by a leaking irrigation pipe from an adjacent property, as observed by Corps personnel during an August 20, 2013 site visit. located in a small isolated depression with no connection to jurisdictional waters. The site was thoroughly investigated by Corps personnel and the consultant for the presence of culverts or ditches leading to jurisdictional waters and none were found. The wetland vegetation on site only exists as a result of the leaking pipe, which does not occur often enough and has not been influencing the site long enough to create hydric soils.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

A portion of the 0.9-acre site was invistigated due to the presence of some wetland vegetation. However, the investigation showed that the vegetation was the result of a nearby leaking irrigation pipe, the only hydrology source. The leaking pipe does not occur often enough to create characteristics of wetland soil. The area in question did not have hydric soils or hydrology. Groundwater was measured by the consultant at a depth of 25 inches during Spring. No wetlands or waters of the U.S. exist within the study area.
