Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There are approximately 0.53 acre of wetlands and 0.13 acre of waters that are not adjacent to nor abutting an RPW or non-RPW. The wetland features consist of a depressional pond and two swales while the other waters consist of two ditches. The USGS quadrangle map shows a historic blue-line feature that went through the site from northeast to southwest and terminated approximately 1.5 miles downstream of the review area. Althouth this feature no longer exists, a faint signature can still be seen in aerial photos within portions of the review area and can be traced through the orchard on the adjacent property to the south. This feature is not consistently visible in recent aerials and does not

connect to Cottonwood Creek or any other tributary. There is no indication that this feature had historical connection to a water of the U.S. The mapped waters are isolated and are not hydrologically or ecologically connected to a TNW.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.





## B. ADDITIONAL COMMENTS TO SUPPORT JD:

There are approximately 0.53 acre of wetlands and 0.13 acre of waters that are not adjacent to nor abutting an RPW or non-RPW. The wetland features consist of a depressional pond and two swales while the other waters consist of two ditches. The USGS quadrangle map shows a historic blue-line feature that went through the site from northeast to southwest and terminated approximately 1.5 miles downstream of the review area. Althouth this feature no longer exists, a faint signature can still be seen in aerial photos within portions of the review area and can be traced through the orchard on the adjacent property to the south. This feature is not consistently visible in recent aerials and does not connect to Cottonwood Creek or any other tributary. There is no indication that this feature had historical connection to a water of the U.S. The nearest RPW is Cottonwood Creek. There is no evidence that these waters are connected hydrologically or ecologically to Cottonwood Creek or contribute to or degrade to the water quality or ecological function of this water or it's tributaries. The mapped waters are isolated, non-navigable, intrastate waters with no hydrologic or ecologic connection to a TNW.
