**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

**None of the potential ephemeral channels contain an ordinary high water mark. Mining operations downstream of the eight ephemeral washes have effectively obliterated any connections that may have existed downstream (Permitted under SPK-1993-00335 and 437 NWP 26 for Headwater Streams). The topography of the surrounding area would make it very difficult, if not impossible, for water to flow into Kelly Creek to the east of the project area. Therefore, none of the "potential" waters have indicators of ordinary high water mark that meet the criterias of a water of the United States.**
