manipulated landscape. At its closest point, Spring Creek (nearest jurisdictional feature) is approximately 220 feet from Wetland E, the closest wetland polygon. Corps personnel surveyed for any indication of drainage patterns or culvert connections to Spring Creek and none were found. A leaking water pipeline contributes (but does not appear to be the sole source) to the hydrology of wetland D. However, this water does not flow out of this depressional area and appears to percolate into the soil. None of these wetlands are located in active floodplain area. Wetlands G, H, J and M are at least 350 feet from the Spring Creek floodplain and separated by an upland berm that also functions as an access road. The Corps has determined that the wetlands evaluated on this form are isolated features. These wetlands have no interstate or foreign commerce connection.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

#### B. ADDITIONAL COMMENTS TO SUPPORT JD:

Wetlands C, D, E, F, G, H, J, K, M and N are isolated features with no surface connection to jurisdictional waters. Each wetland polygon is located in an individual depressional area entirely surrounded by uplands. The nearest TNW is Utah Lake, which is approximately 2 miles west of the study area. At its closest point, Spring Creek is separated from the wetlands by approximately 220 feet of uplands with no drainage connection. No culverts were found during an inspection by Corps personnel. Based on the lack of hydrologic connection to Utah Lake and no interstate commerce, the Corp has determined the 6.18 acres of isolated wetlands within the site to be non jurisdictional features and seeks EPA concurrence.

Spring Creek, Unnamed Channel and Wetlands A and B are being evaluated as jurisdictional features on a separate JD form.




Figure 1. Site Location Map. Map showing 1:100K USGS topographic mapping.




Figure 3A. Wetland Delineation Map (Overview).
