Explain: The project area contains 1.14 acres of seasonal wetlands and historic water discharge areas (HDWA), which are isolated, intrastate waters, with no interstate or foreign commerce connection. The two HWDA areas, HWDA-1 and HWDA-22, consist of areas where treated groundwater was routinely discharged by Aerojet from their Groundwater Extraction and Treatment System, as required by Federal, state, and local agencies for cleanup of contaminated groundwater associated with

Supporting documentation is presented in Section III.F.

SW-19, SW-20, SW-23, SW-24, SW-25, and SW-26, are located within an area that was historically dredge mined for gold, and do not have a surface connection to other waters of the U.S. These features were previously determined to be non-jurisdictional by the Corps for the Westborough at Easton site (SPK-2005-00852), on Janaury 31, 2008. As shown on the attached LiDAR map, the HWDAs and SWs do not have a hydrologic connection to any relatively permanent water (RPW) or traditionally navigable water (TNW). On the north-side of the project area, SW-17 is the closest water to a RPW, and is approximately 1/2 mile from Buffalo Creek to the north. On the south-side of the project area, SW-23 is approximately 1/3 mile from an unnamed tributary to Morrison Creek. Therefore, we have determined that these waters are isolated, intrastate waters with no interstate or foreign commerce connection, and therefore are not jurisidictional.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.


