C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Utah Lake is a navigable-in-fact TNW. The study area included 0.41 acres (1,170.5 linear feet) of Utah Lake open water and 1.12 acres of directly abutting wetlands, both of which are jurisdictional. The 0.06-acre pond is a man-made feature, excavated in uplands. As such, the Corps has determined the pond to be a non-jurisdictional feature. This is a re-evaluation of the study area which was previously reviewed and an Approved Jurisdictional Determination was issued June 24, 2014. The previous determination also found that the excavated pond was not a jurisdictional feature. The acreage of the jurisdictional features on site has been reduced as a result of a more extensive survey.
