Tecuya Creek is an ephemeral drainage that receives and carries water only during extreme storm events. Within the project boundary, the creek ranges in width from approximately 34 to 115 feet. However, the actual channel where water normally flows during heavy rain events, outside of a flash flood, is about two to three feet wide, and in some places narrower. The channel crosses through the project location

approximatley 13 miles from its origin, adjacent to Highway 99 and proceeds northwest as it converts from a natural channel into an agricultural ditch collecting irrigation run-off and other possible surface flows from adjacent fields. Approximately 7.5 miles from the project site, the channel runs west; adjacent to, and crossing under Copus Road, then running northwest parallel and adjacent to Interstate 5, terminating in the historical Kern Lake Bed at approximately Latitude 35.106254°, Longitude -119.044233°,

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Tecuya Creek originates on the slopes of Tecuya Ridge, slightly northeast of Tecuya Peak in the San Emigdio Mountain Range. When water is present, typically only during extreme storm events, the creek flows to the north and traverses a large alluvial fan area on the northern flanks of the San Emigdio Mountains. Along with other adjacent drainage channels, Tecuya Creek is intercepted and funneled to an underpass crossing beneath the California Aqueduct approximately 2 miles southwest of the project location. In total, the creek runs approximately 23 miles before terminating near the Kern Lake Bed. Tecuya Creek does not have a hydrologic connection to a traditional navigable water of the U.S. and does not have a nexus to interstate commerce.
