drainage (Drainage 1). Cottonwood Creek and Brock Creek are perennial drainages fed by springs. Drainage 1 is ephemeral and channels only stormwater. Three wetlands associated with springs were identified within the Brock Creek drainage 27-49-14-413, 28-49-30-231, and 28-49-30-443. Twelve wetlands associated with springs were identified within the Cottnwood Creek area 27-49-12-112, 27-49-12-114, 27-49-12-122, 27-49-12-141, 28-49-20-241, 28-49-20-442, 28-49-21-314, 28-49-27-441, 28-49-28-123, 28-49-35-311, 28-49-36-322, 28-49-36-323. All fifteen wetlands directly abut or are adjacent to the main drainages. All three main drainages terminate in Crescent Valley which is a closed hydrologic basin with no connection to a TNW.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.


#### **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

The study area is located in the Crescent Hydrographic Area in the Humboldt River Basin. The Humboldt River is about 20 miles from the study area. Precipitation measurements collected at the Cortez Mine site in the study area totaled about 10.4 inches from September 2012 to September 2013. The three main drainages within the area are Cottonwood Creek, Brock Creek, and an unnamed drainage (Drainage 1). Cottonwood Creek and Brock Creek are perennial drainages fed by springs. Drainage 1 is ephemeral and conveys flows only in response to precipitation events.

Three wetlands associated with springs were identified within the Brock Creek drainage 27-49-14-413, 28-49-30-231, and 28-49-30-443. Twelve wetlands associated with springs were identified within the Cottnwood Creek area 27-49-12-112, 27-49-12-114, 27-49-12-122, 27-49-12-141, 28-49-20-241, 28-49-20-442, 28-49-21-314, 28-49-27-441, 28-49-28-123, 28-49-35-311, 28-49-36-322, 28-49-36-323. Additional information regarding each of these wetlands can be

found in the delineation report "Cottonwood Creek and Brock Creek Preliminary Jurisdictional Assessment" pepared by HDR, Inc, dated October 31, 2014.

All fifteen wetlands directly abut or are adjacent to the main drainages. All three drainages terminate in agricultural fields within Crescent Valley with no surface or sub-surface connection to the Humboldt River. Cottonwood Creek and wetlands 27-49-12-112, 27-49-12-114, 27-49-12-122, 27-49-12-141, 28-49-20-241, 28-49-20-442, 28-49-21-314, 28-49-27-441, 28-49-28-123, 28-49-35-311, 28-49-36-322, 28-49-36-323; Brock Creek and wetlands 7-49-14-413, 28-49-30-231, and 28-49-30-443; and Drainage 1 are intrastate isolated waters with no apparent interstate or foreign commerce connection.





## Cottonwood Creek and Brock Creek Preliminary Jurisdictional Assessment







Hydrographic Basin Map








