If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

#### B. ADDITIONAL COMMENTS TO SUPPORT JD:

Within the survey area there are Pine Grove Canyon, Scott's Canyon, Rockland Canyon, eight unnamed ephemeral drainages and Pine Grove Spring that convey rain and snowmelt runoff. Water drains from southwest to northeast within the survey area. Along the east side of Pine Grove Flat (the valley where the potential waters drain) there is an unnamed drainage This drainage flows north towards the Walker River and would capture waters flowing from Pine Grove Hills. The survey area averages 5.06 inches of precipitation per year. The East Fork Walker River is approximately 12 aerial miles from the survey area.

Only five of the eleven drainages, Pine Grove Canyon, Drainages 2, 3, 4, and 6, experience sufficient flow to have developed an OHWM; however, the OHWM for all drainages terminate outside of the survey area before reaching a jurisdictional waterway. Pine Grove Canyon is the primary drainage feature within the survey area draining from the southwest corner of the survey area to the northwest corner. Pine Grove Canyon has been heavily altered by historical mining activities. Drainage 6 confluences with Pine Grove Canyon where the OHWM begins within the survey area. One spring, Pine Grove Spring, occurs within the survey area adjacent to Pine Grove Canyon. Pine Grove Canyon loses OHWM indicators once it reaches the valley floor prior to converging with a water of the U.S.

Drainage 2 is the southern most drainage and flows from south to northeast within the survey area. Drainage 3 confluences with drainage 2 outside of the main survey area in the vicinity of the haul road. Drainage 2 loses OHWM indicators once it reaches the valley floor prior to converging with a water of the U.S.

Drainage 4 begins on the east side of the survey area near the center and flows northeast maintaining an OHWM until it reaches the valley floor prior to converging with a water of the U.S.

Pine Grove Canyon, Pine Grove Spring, and Drainages 2, 3, 4, and 6 are intrastate isolated waters with no apparent interstate or foreign commerce connection.
