no potential for these ditches to connect to downstream jurisdictional waters. Utah Lake, the nearest TNW, is approximately 0.5-mile south of the study area. The wetland identified as W01 occurs in a slight depression area in the middle of an agricultural field near the terminus of Ditch 2. This feature is completely surrounded by uplands. Hydrology for W01 comes from irrigation practices on the surrounding agricultural field- excess irrigation water drains and gathers in this low spot. This source of hydrology is not sufficient to increase the size of the wetland to create a connection to any other feature. No other channels or wetland features exist near W01 that could convey flows beyond the wetland boundary.

Ditch 1, Ditch 2 are not waters since they were excavated out of dry land for purposes of conveying irrigation flows and have no connection to downstream waters. W01 is an intrastate, isolated feature with no connection to any other aquatic features and has no interstate or foreign commerce connections. The Corps has determined that these 3 features are not jurisdictional.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
