C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Buckeye Creek is a natural channel system located within the southern portion of the review area. This creek is typical of drainages in the arid west and has three distinctive hydrogeomorphic components: a low-flow channel, active floodplain, and low terrace. Channel widths are variable within this system, being narrower and constrained in the eastern portions and widening to a larger alluvial floodplain in the western sections. Riparian vegetation present in the system includes ephedra and willows on the banks of the low-flow channel and more facultative upland species such as rabbit-brush, Russian thistle, and sagebrush on top of banks and in the low terrace. Although this system is disturbed and altered by adjacent agricultural activities and hydrological modifications, it is intact and provides important wildlife corridor habitat and hydrological functions. This creek connects to the East Fork of the Carson River, a TNW, through numerous natural and man-made conveyances.
