separated from each other by 30 or more feet and are isolated from any connection to other waters. The wetlands were determined to be jurisdictional in a 2008 Approved Jurisdictional Determination. Since the 2008 determination the upland areas in between the wetlands were raised with fill material. There is a culvert on the southern edge of the property that leads to an upland stormwater ditch on the other side of 1200 North. However, the wetlands are depressional, the opening of the culvert, which is now partially buried, is topographically higher than the wetlands. Because the wetlands are primarily groundwater driven, there is no potential for them to fill up enough to spill over into each other or into the culvert to connect to the stormwater ditch. For such a connection to occur the entire site would need to be inundated with 1-3 feet of water, which is highly unlikely under normal circumstances. Therefore, Wetlands A, B, and C in the North Parcel are recommended as isolated wetlands and not jurisdicitonal.

On the South Parcel, Wetlands D (0.015 acre) and E (0.017 acre) are also depressional, wet meadow wetlands. These wetlands were originally part of a large wetland that was identified in the 2008 Jurisdictional Determination. Results from the December 1, 2014 wetland delineation and a November 3, 2014 site visit show that this wetland area has largely dried up as the hydrology has changed significantly. The plant community has shifted towards upland dominated species. Construction of the nearby Legacy Highway on the eastern edge of the property may have contributed to the change in groundwater hydrology. Wetlands D and E are marginal wetlands with FACU species. The plant community has shifted to being comprised of upland species and there are no hydrology indicators that suggest that these wetlands sheetflow into adjacent waters or into any other water or conveyence. Further, these wetlands are primarily groundwater driven and do not receive surface flows that would enable them to spill outside of their delineated boundaries. Wetland F (0.009 acre) abuts an upland ditch, identified as ditch 2, that lacks an ordinary high water mark. This ditch continues for 750 linear feet to the west where it connects to the sewer treatment plant's wastewater treatment pond. Wetland F is a very small, primarily groundwater driven, wetland that under normal circumstances does not flow outside of its delineated boundary. For such a connection to occur the entire site would need to be inundated with 1-3 feet of water, which is highly unlikely under normal circumstances The distance that water from Wetland F would have to flow, 750 linear feet, indicates that Wetland F is an isolated water and not jurisdictional.

Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the

significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. The determination whether a significant nexus exists is determined in Section III.C below.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:




Figure 1. Project Area Location Map - 1:100,000 Topographic Base




Figure 6. South Parcel Wetland Delineation Map South Davis Sewer District Expansion Area West Bountiful, Davis County, UT Wetland Delineation Technical Report




Figure 3. North Parcel Wetland Delineation Map
