The Colorado River is listed on the USACE-Sacramento website (http://www.spk.usace.army.mil/organizations/cespk-co/regulatory/nv_waterways.html) as a navigable water from the Nevada/Arizona border to the Nevada California Border, a reach of about 145 miles, which includes Lake Mohave and Lake Mead.
