South DikeToe Ditch (5,158 LN FT), Pond 113 South Pond Dike Toe Ditch (47,337 LN FT), Dike Toe Ditch (11,731 LN FT) and the Canal to GSL (4,525 LN FT) that were excavated in dry land. Pond 114 and 133 toe ditches and Canal to GSL were constructed for purposes of conveying water from the mineral mining process. The Dike Toe Ditch was constructed to convey surface water away from the railroad berm. Additionally, there is an abandon salt pond operation on the south east portion of the project area located south of the railroad grade. These ponds were created in dry land. The ponds themselves do not exihbit waters characteristics such as OHWM or wetlands.

Summarize rationale supporting determination: The GSL meets the criteria of having been found to be navigablein-fact under Federal law in Utah v. United States, 403 U.S. 9 (1971). As such, the GSL is a "traditional navigable water" and is regulated by the Corps under Section 404 of the CWA. Approximately 528.42 acres of the Lakeside Lease Area 2 project is located below 4199 feet MSL which is considered part of the Great Salt Lake, as this elevation is considered the ordinary high water mark (OHWM) of the lake. This OHWM was set in policy in the September 28, 2015 Regulatory Division Memorandum 2015-02.

# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.




