Wetland C is located approximately 700 feet from Wetland B/Lost Creek, and there is no hydrologic connection.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The project area has been divided into two separate jurisdictional determinations (JD). This JD form covers the 0.25 acres of isolated wetland and 143 linear feet of isolate drainage. A separate form was developed for the jurisdictional significant nexus waters, RPW, Non-RPW's and directly abutting wetlands, totaling 2.86 acres of palustrine emergent wetland, 272 linear feet of perennial drainage, and 1,818 feet of ephemeral drainage.

Non-jurisdictional Isolated Waters-

Two non-jurisdictional features were identified within the project site of 126 acres. Drainage 4 is 143 linear feet and flows through an upland swale into the isolated Wetland C. Wetland C is 0.25 acres and comprised of *Agrostis*

stolonifera and *Juncus balticus*. Wetland C is located approximately 700 feet from Wetland B and Lost Creek, the nearest jurisdictional features. These isolated features are upslope from jurisdictional Wetland B, and this upland area is mainly comprised of Big Mountain Sage. Located approximately 250 feet northwest of the isolated Wetland C, within the 700 feet of upland, there is a historic upland swale. It is evident this upland swale does not have sufficient flows to develop an ordinary high water mark, since the channel is comprised mainly of upland species and shows no recent flow indicators, such as accretion patterns. These waters do not have a biological, chemical and hydrological connection with downstream waters, nor are these waters associated with activities utilized for interstate commerce (ex. gravel mining). Therefore the Corps has determined Wetland C (0.25 acres) and Drainage 4 (143 linear feet) to be isolated and non-jurisdictional.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The project area has been divided into two separate jurisdictional determinations (JD). This JD form covers the significant nexus waters, RPW, Non-RPW's, and directly abutting and adjacent wetlands. A separate form was developed for the 0.25 acres of isolated wetland and 143 linear feet of isolate drainage.

RPW, Non-RPW's and Directly Abutting Wetlands-

The site has four directly abutting wetland areas and three jurisdictional drainages. Wetlands A (0.07 AC), B (0.81 AC) and F (0.14 AC) directly abut Drainage 2 (272 LF), which is Lost Creek, a relatively permanent waterway. Wetland E (1.75 AC) directly abuts Drainage 5 (330 LF) an ephemeral non-RPW channel, which flows into Lost Creek. Drainage 1 (1,276 LF) is an ephemeral non-RPW and also flows into Lost Creek. These waters have been determined to be jurisdictional, since they directly abut and flow into Lost Creek, a tributary of the Weber River, a tributary of the Great Salt Lake, the nearest TNW.

Adjacent Waters-

Wetland D (0.09 AC) and Drainage 4 (212 LF) are connected with the nearest Wetland E, located approximately 150 feet northwest, through an upland swale. This wetland and drainage are fed by an approximately 70 acre watershed south of Browns Canyon Road, which has a small seep/spring located at the headwater. Between the size of the watershed and seep/spring there are sufficient flows to connect hydrologically through this upland swale. Therefore, it has been determined that Wetland D and Drainage 4 are jurisdictional, since they have a significant nexus with the Great Salt Lake, the nearest TNW.

Due to the hydrologic connection with the Weber River and the Great Salt Lake (nearest TNW), it has been determined by the Corps that the Wetlands A (0.07 AC), B (0.81 AC), D (0.09 AC), E (1.75 AC); and Drainages 1 (1,276 LF), 2 (272 LF), 4 (212 LF), and 5 (330 LF); totaling 2.86 acres of wetland and 1,818 linear feet of drainage, are jurisdictional.
