Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The irrigation ditches on site span 1,365 linear feet of the parcel. As both ditches were constructed in uplands for agricultural purposes, the flow of water can be turned on and off using the diversion structure at the southeastern corner of the property, and thus, neither is considered a regulated feature. Both features show no obvious connections to any streams or tributaries, although the irrigation ditch along the eastern edge of the property appears to lead to a wetland which is adjacent to an unnamed irrigation canal of Beaver Creek. Utah Lake, as the nearest TNW, is approximately 35 miles southwest of the property.**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

The study area is comprised of 15.02 acres in which the wetlands are dominated by Nebraska sedge, Meadow foxtail, and California field sedge, while the upland areas are dominated by Nebraska sedge, California field sedge, Sierra rush, Bearded fescue, and Common dandelion. The two irrigation canals running along the eastern edge and north to south through the middle of the property are both lacking in any surface connection to any of the neighboring streams. In addition, the flow through these two drainages can be controlled via a diversion structure at the southeastern corner of the study area. Both ditches are considered non-jurisdictional.

The only wetland in the study area is 1.23 acres of palustrine emergent wetland, and is part of a large wetland complex that spans several parcels. This wetland was evaluated for a significant nexus, and the Corps has determined that this is a jurisdictional wetland with surface connections to the unnamed irrigation canal which flows to the Provo-Weber Canal and eventually connects to Utah Lake, the closest TNW.

Two neighboring parcels, under US Army Corps of Engineers file numbers SPK-2004-50291 and SPK-2002-50348, were assessed for jurisdiction under the Clean Water Act Section 404. In 2004, a jurisdictional determination was made concerning a property to the west of the wetland in question. It was determined that 10.4 acres of the 52 acre site were considered jurisdictional wetlands. The same decision of jurisdiction was reached after the review of 3.6 acres of wetland on a site northwest of the parcel in question in 2002. Both of these sites contain wetlands that appear to be part of the same wetland complex that is present on the parcel currently being examined.

Utah Lake is listed as an impaired water for total phosphorus and total dissolved solids. The wetlands on site, and in conjunction with other similarly situated wetlands in the area, help to remove phosphorus and dissolved solids prior to entering the open water tributary systems which connect with Utah Lake.
