- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **A total of 0.12 acre of aquatic resources are irrigation ditches dug in dry land that do not act as tributaries. This determination is in accordance with the 1986 preamble to 33 CFR Part 328.3, which states that the Corps generally does not consider non-tidal irrigation ditches excavated on dry land to be waters of the US. These features includes areas AA (219 square feet (sf)), H (1,973 sf), I (312 sf), M (292 sf), O (319 sf), , CC (267 sf), FF (205 sf), GG (284 sf), and HH (1,160 sf). A total of 0.07 acre of aquatic**

resources are wetlands whose sole source of hydrology is a leaky irrigation ditch. This determination is in accordance with the 1986 preamble to 33 CFR Part 328.3, which states that the Corps generally does not consider artificially irrigated areas which would revert to uplands if the irrigation ceased to be waters of the US. These features include BB (798 sf), MM (670 sf), and OO (1,388 sf). Area NN (735 sf) is a stock pond dug in dry land. This determination is in accordance with the 1986 preamble to 33 CFR Part 328.3, which states that the Corps generally does not consider artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering and irrigation as waters of the U.S. There are a total of 0.20 acre of aquatic resources that were assessed within the review area and determined to be not jurisdictional.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The project proponent requested an approved jurisdiction determination for Areas H, I, M, O, P, AA, BB, CC, FF, GG, HH, MM, NN, and OO within the review area. Of the areas reviewed, Area P was the only area that is considered a waters of the US, since it conveys water from Salt Creek to the Florida River and contains relatively permanent flow. All other areas were requested to be reviewed as a preliminary jurisdiction determination in which we assume these areas are waters of the U.S.
