C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.




B. ADDITIONAL COMMENTS TO SUPPORT JD:

Dump Creek is a perennial stream that drains to Birch Creek. Hydrology within Dump Creek is sustained by springs in the headwaters and surface runoff from rain and snow. Birch Creek is perenial in the upper reach and intermittent at the confluence with Dump Creek. Hydrology is sustained by groundwater and surface runoff. Birch Creek drains into agricultural fields within the Big Smoky Valley

Big Smoky Valley is situated in a closed hydrologic basin with no outlets and no tributary connections to a Traditional Navigable Water (TNW). The nearest TNW-NIF is Walker Lake which is approximately 85 miles west of the project boundary. Mining may be used as a basis for establishing an interstate commerce connection; however, none of the water from these tributaries are used in mining operations. There is no use by foreign or interstate travelers for recreation or other purposes; there are no fisheries; and there are not any other commercial endeavors being conducted on the waters identified in the study area. There is no apparent interstate or foreign commerce connection.

Dump Creek and Birch Creek are intrastate isolated waters.
