Summarize overall biological, chemical and physical functions being performed: **These wetlands perform several functions important to the biological, chemical and physical integrity of Dry Creek. This nexus is neither speculative nor insubstantial. These wetlands, along with other similarly situated wetlands in the watershed, store precipitation and slowly deliver this water directly into Dry Creek.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

**Parcel A is located within the active floodplain of Dry Creek. As such, it is subject to overbank flooding from Dry Creek and a relatively high water table on relatively low elevation floodplain terraces that are immediately adjacent to Dry Creek. In addition, on an as needed basis, the Dry Creek Ranch Golf Course managers pump water from ponded depressions on the golf course through a six-inch PVC pipe to the northeastern side of Parcel A. This area supports a combination of riparian woodland, riparian shrub-scrub, and emergent wetlands that are directly connected to the main stem of Dry Creek. Their total area is 30.98 acres. Because of the documented direct hydrologic connections of these floodplain wetlands with the Dry Creek ecosystem, we have determined that these wetlands are under Federal jurisdiction.**
