C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The 568 linear feet of perennial drainage ditch identified on site carries storm water and other surface runoff from surrounding development. Past information (Approved JD, SPK-2006-50305) suggests that this feature also carries flow that originates from perennial springs to the east of the study area. Additional development has occurred since the previous determination, which is likely to have increase flow to the channel due to an increase in impervious surfaces. Flow leaves the site under I-15 to the south and continues through a series of ditches until it reaches Utah Lake, the nearest TNW, approximately 1 mile southwest of the study area.
