Explain: **The subject area is Gleason Creek where it flows through the property owned by the Robinson Nevada Mining Company, located directly northwest of the town of Ely in White Pine County, Nevada. Gleason Creek is an intermittent stream that flows through the Steptoe Basin to Murray Creek which flows to Steptoe Creek which flows to Tailings Creek then Duck Creek and finally empties into Goshute Lake which straddles the border of White Pine and Elko Counties. Goshute Lake lies within the Goshute Valley, a closed hydrological basin with no outlets and no tributary connections to Traditionally Navigable Waters. The topography in the Goshute Valley directs water flows to the valley floor where they are evaporated or**

transpired by plants. Goshute Lake is located in a closed hydrologic basin, is not considered a Navigable-in-Fact waterway and has no connection to interstate commerce.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

**On August 30, 2007, the USACE issued an approved jurisdictional determination for Gleason Creek, under this same action ID (SPK-2007-00715), which "... determined that Gleason Creek, in accordance with 33 CFR, Section 328.3(a)(3), is not a jurisdictional water of the United States and as such is not regulated under Section 404 of the Clean Water Act." The 2007 approved jurisdictional determination has expired, hence the request for this approved jurisdictional determination for the same stream on the same property.**
