C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The project site contains 3 segments of concrete-lined irrigation ditch (Ditch A= 2,657 linear feet, Ditch B= 2,855 linear feet, Ditch C= 1,086 linear feet), a segment of earthen ditch (184 linear feet), a segment of the Piute Canal (2,907 linear feet) and a retention pond (0.38 acre). Each of these features have ordinary high water mark (OHWM) indicators. Each individual feature was thoroughly investigated and found to have no connection to a downstream jurisdictional feature. All features on site are man-made, constructed in uplands, drain only uplands and have been highly disturbed and manipulated for agricultural purposes. Piute Canal is a man-made canal, constructed in uplands, which runs through the northern portion of the project boundary, then flows north approximately 29 miles and terminates in stock ponds 1 mile west of Yuba Reservoir. Outlet structures release water from the canal at diversions along the northward path to adjacent farm fields. Each outlet was investigated and no connection to jurisdictional waters exists along the entire reach of Piute Canal from the project area to where it terminates. The retention pond is an artificial, constructed pond that has an outflow culvert on its south bank approximately 10 feet above OHWM. During extreme events, it is possible that outflow from the retention pond would flow through the culvert and drain into an alfalfa field to the south. However, there is no potential connection between the pond and other jurisdictional waters. The Corps has determined that all features identified on site do not meet the definition of waters of the United States and are non-jurisdictional.

Piute Canal was previously determined to be a non-jurisdictional feature (SPK-2015-00769). All aquatic features on site were excavated in uplands, drain only uplands, do not flow into other waters and do not meet the definition of waters of the United States. The site consists entirely of uplands or upland features.
