Explain: **The 0.28 acre of palustrine emergent wetland located within the 13.92 acre property is isolated. This wetland does not have a physical, biological or chemical connection with Logan Northern Canal, the nearest relatively permanent waterway. The Logan Northern Canal is located approximately 0.6 miles west of the 0.28 acre of wetland. The wetland is depressional has no outlet and is located on a hillside. No secondary irrigation ditches or ephemeral drainages could be identified nearby off of topo maps, aerial photographs or during the May 10, 2016 site visit. In addition to the lack of physical connection the wetland has no associated interstate commerce.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The Corps has determined the 0.28 acre of palustrine emergent wetland within the 13.92 acres Peterson Property is isolated. This wetland has no physical, chemical or biological connection with the the Cutler Reservoir, the nearest TNW. The subject wetland is a manmade depression designed to capture overland flows from the hillside and groundwater for irrigation/stockwater purposes. Also, this wetland does not have any associated interstate commerce. Therefore, the Corps has determined this wetland to be isolated and non-jurisdictional.
