Wetlands B, D, E, F, K, Q, R, S, T and U are Palustrine Shrub-Scrub Wetlands which are directly abutting the Uncompahgre River.

Wetland C is a 0.33 acre Palustrine Emergent Wetland that is adjacent to, but not abutting, the Uncompahgre River. It is located at the edge of the upper floodplain terrace, just below a break in slope between that terrace and another higher river terrace. The terrace where the wetland occurs is dominated by cottonwood riparian woodland, which appears to benefit from irrigation tail water.

Wetland G (0.13-acre) is a Palustrine Scrub Shrub Wetland that is adjacent to, but not abutting, the Uncompahgre River. It is located on the west side of the Uncompahgre River below a pond berm that is

located just outside the survey area on its western boundary (see 33 CFR 328.3(c)). Standing water occurs in portions of the wetland closest to the berm. Wetland L (0.25 acre) and Wetland M (0.15 acre) are Palustrine Emergent Wetlands adjacent to, but not abutting, the Uncompahgre River. These wetlands formed in pits dug in the upper terrace of the river in the northern portion of the survey area. The purpose of the excavations remains unknown, but likely involved gravel mining given the existing soils at that location.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its

adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
