the Needles Highway. Here, stormwater from the washes enter roadside ditches, and are conveyed to several culverts installed underneath the Needles Highway. Water that flows through these culverts continues traveling southeast until reaching the historical Colorado River floodplain. The escarpment that marks the boundary of the floodplain was closely investigated. This location shows clear indications that water pools and does not continue to flow beyond that point. Where washes meet the escarpment, significant mud cracking is observed, indicating that water ponds and deposits its sediment load, and no channel extends beyond this location, approximately 0.83 miles from the Colorado River at its closest point. The thick stand of tamarisk along the edge of the floodplain also prevents any water from continuing beyond this location. Therefore, these waters are intrastate, isolated non-navigable waters without any identified connection to interstate commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
