If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The 450-acre study area contains approximately 1.44 acres of emergent marsh, 47.58 acres of vegetated mineral flats, 24.44 acres of wet meadow, and 3,646 linear feet of channel which have been determined to be jurisdictional. The 73.46 acres of wetland and 3,646 linear feet of channel either directly abut or are an RPW of the Great Salt Lake, the nearest TNW (between 1 and 3 mile north). The 2016 study area increased in size slightly by 0.32 acre from the 2010 survey area. The entirety of this addition is comprised of mineral flat (playa). This addition of the survey area changed MF-7 from 3.21 acres of mineral flat to 3.53 acres.

MF-1 is classified as vegetated mineral flat and mainly comprised of greasewood (*Sarcobatus vermiculatus*). There is no physical connection with the Great Salt Lake (nearest RPW), at least 3 miles north; or with the nearest RPW, at least 2,900 feet north.

In April 2010, under a previous jurisdictional determination, the Corps determined MF-1 (2.13 acres) to be isolated and non-jurisdictional. This was due to the lack of, and no potential for, a physical connection with the Great Salt Lake (nearest TNW), and no associated interstate commerce; the Corps determined these 2.13 acres of vegetated mineral flat as non-jurisdictional. MF-1 still lacks a physical connection and has no associated interstate commerce, therefore MF-1 remains non-jurisdictional. EPA coordination was not required since the MF-1 site conditions have not changed since April 2010.
