Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There are two isolated non jurisdictional ephemeral streams, Features 3 and 4. There are also five isolated non jurisdictional wetlands (Wetlands 1, 2, 3, 4 and 5) totaling 0.43 acre within the project.

Features 1, 2, and 5-10, all lack any indication of OHWM and are not jurisdictional.

Feature 3 is an approximately 2.5 foot wide channel originating within the project from other drainage features including features 1 and 2. Feature 3 has ephemeral flows which are sufficient to create an OHWM for approximately 878 feet. Feature 3 flows westward out of the project, connecting to a complex of springs which flow perennially into Thacker Creek. Thacker Creek then flows into an irrigation impoundment used to irrigate a nearby field. There is no indication of any connection of flows from Thacker Creek to Kings River, the closest potential

jurisdictional water approximately 2 miles from the irrigation impoundment. Feature 3 has no known connection to interstate commerce. Feature 3 may have had a pre-agricultural connection to Kings River; however, this remains speculative based on the evidence provided by the applicant aerial photos and USGS Mapping.

Feature 4 is an approximately 2.5 foot wide channel showing indicators of an OWHM. Feature 4 is a 1<sup>st</sup> order tributary to Crowley Creek connecting to it approximately 4 miles east of the project area. Crowley Creek splits into several diverging branches. The branch with perennial flow was determined to end in a pasture approximately 5.5 miles from the eastern boundary of the project, and approximately 2.5-3 miles from the Quinn River. Aerial photography and USGS mapping confirm there is no current surface connection between Crowley Creek and the Quinn River. A pre-agricultural connection between Crowley Creek and the Quinn River is speculative only. Feature 4 has no known connection to interstate commerce.

There are five wetlands present within the project areas totaling approximately 0.43 acres. Wetlands 1 and 2 are located more than 1000 feet from a mapped feature with no OHWM, and more than a mile from feature 4. Wetlands 3 and 4 are artificially supported by water pumped in to stock ponds and would dry up without the water supply. Wetland 3 is located near feature 9 which lacks an OHWM, but does show connection to feature 4. Wetland 4 is an isolated wetland formed around a stock pond which could have a connection to feature 10 which drains toward feature 4. Wetland 5 is located within the channel of feature 4. Since Feature 4 is an isolated channel with no connection to waters of the US or interstate commerce, wetlands 1-5 are also isolated features and non-jurisdictional.

**C. SIGNIFICANT NEXUS DETERMINATION:**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
