C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: South Bell Creek enters the project site from the northeast and is diverted through a man-made channel (referred to as South Bell Creek Diversion and South Bell Creek Riparian

within the current delineation report) for 0.9 miles before converging with Bell Creek. South Bell Creek is a tributary of Bell Creek.

Bell Creek enters the project site from the north and flows for 4.2 miles through its natural channel before converging with Rodeo Creek. Bell Creek is a tributary of Rodeo Creek.

Brush Creek enters the project site from the east and is diverted through a man-made channel for 2.8 miles before converging with the Rodeo Creek diversion. Brush Creek is a tributary of Rodeo Creek.

Rodeo Creek is currently being diverted through a buried 72 inch diameter pipeline for 2.7 miles (14,256 linear feet) within the project site. Additionally, Rodeo Creek is being diverted through man-made channels for approximately 0.2 miles. Of the original 4.8 miles of natural stream channel that Rodeo Creek flowed through prior to being diverted, 1.1 miles of natural stream channel remain. Although Rodeo Creek is being piped through a large portion of the site, it is still included in the estimated total for non-jurisdictional waters in the review area (Section III: CWA Analysis, F). Rodeo Creek is a tributary of Boulder Creek.

Boulder Valley has a drainage area of approximately 370 square miles (236,600 acres). The gradient of Boulder Valley averages approximately 11 feet per mile or a 0.2% slope. In this flat valley setting, the Boulder Creek channel braids and meanders considerably as it flows south through the valley, greatly increasing the distance over which water must pass to reach the Humboldt River. Although the straight line distance between the project area and the Humboldt River is approximately 25 miles, the actual flow path to the river would be twice the distance if measured in stream miles (48-55 miles).

Boulder Creek was determined to be isolated on August 13, 2010, by the Corps after coordination with EPA Region 9 and again November 17, 2011. South Bell Creek, Bell Creek, Brush Creek, and Rodeo Creek are all upper tributaries of Boulder Creek.

The Corps has determined that South Bell Creek, Bell Creek, Brush Creek, Rodeo Creek, and Boulder Creek are intrastate isolated, non-navigable waters with no interstate commerce connection.
