Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The study area consists primarily of agricultural operations and contains 4 wetland areas totaling 1.05 acres, a 490-foot segment of ditch and a 625-foot segment of canal. All of these features are isolated from any jurisdictional waters.

The 0.47-acre wetland is a man-made pond that was historically used for irrigation storage but has been abandoned in recent years. The hydrology of this feature is sustained by tile drains that flow in at the north end, while leaking from the southern extent of the pond seasonally supports the adjacent 0.11-acre wetland area. The

0.13-acre and 0.34-acre wetlands further east in the study area are supported by seeps from the hillside that provide hydrology during the growing season due to a higher water table.

The 490-foot ditch along the western boundary dissipates as it flows south and east into a field. The 625-foot canal in the upper portion of the study area flows west and north toward Utah Lake, but is diverted and used at multiple locations along the way. All water in the canal is eventually used up and the canal disappears before flowing into the Spanish Fork River or Utah Lake.

All features identified in the delineation were examined by Corps staff during 2 separate field visits to verify isolation. No connections to other waters were found and there is no apparent interstate or foreign commerce connection with any of the features on site. The nearest TNW is Utah Lake, approximately 5.5 miles northwest of the study area. The Corps has determined that all features on site are intrastate, isolated non-navigable waters with no connection to interstate commerce, thus would not be regulated under Section 404 of the Clean Water Act.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
