Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Drainage 6 does not have indications of an OHWM where it enters the project area, but an OHWM begins where water from surrounding areas collects in the drainage, and continues for 6,042 feet within the project area before being lost again. Drainage 6 has no connection to a TNW. Drainage 7 has no indication of an OHWM where it enters the project area, but OHWM indicators start as it exits the Ruby Hill Mine site, continue 6,074 feet within the project area, and are lost as it leaves the project area into an agricultural field, and has no connection to a TNW. Drainage 9B has indications of an OHWM

where runoff enters it from a nearby road, and continues for 5,738 feet within the project area. OHWM indicators are lost within the project area, and it has no connection to a TNW. Drainage 9C shows no sign of an OHWM until it exits the Ruby hill mine site where it continues for 1,560 feet where it converges with Drainage 9B. Drainage 9C has no connection to a TNW. Drainage 14 exhibits an OHWM within the project area which continues for 9,776 feet before leaving the project area where it ends in an agricultural field, and has no connection to a TNW.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

## **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

There were 28 ephemeral drainages indicated within the November 9, 2012 survey area. Drainages 1, 2, 3, 12, 15, 16, 17, and 18 do not lie within the project area and have been removed from the current delineation. Of the 20 potential aquatic resources within the project area, features 4, 5, 7, 9, 9A, 10, 11, 13, 19, 20, 21, 22, 23, 24, and 25 did not exhibit an OHWM or any connection to a TNW.

Five of the drainages, 6, 7, 9B, 9C, and 14, within the project area exhibit indications of an OHWM within the refined project area. Drainage 6 does not have indications of an OHWM where it enters the project area, but an OHWM begins where water from surrounding areas collects in the drainage, and continues for 6,042 feet within the project area before being lost to substrate. Drainage 7 has no indication of an OHWM where it enters the project area, but OHWM

indicators start as it exits the Ruby Hill Mine site, continue 6,074 feet within the project area, and are lost as it leaves the project area at an agricultural field. Drainage 9B has indications of an OHWM where runoff enters it from a nearby road, and continues for 5,738 feet within the project area. OHWM indicators are lost within the project area. Drainage 9C shows no sign of an OHWM until it exits the Ruby hill mine site where it continues for 1,560 feet where it converges with Drainage 9B. Drainage 14 exhibits an OHWM were it enters the project area and continues for 9,776 feet before being lost to substrate. This drainage enters a detention basin prior to entering agricultural flows ceasing flows outside of the project area.

All drainages within the project area are located within the Diamond Valley a hydrologically closed basin. All waters on the project site have no connection to a relatively permanent water or traditional navigable water; are not navigable; nor do they have a commerce connection; therefore drainages 6, 7, 9B, 9C, and 14 with a combined length of 29,190 feet and are isolated waters.
