Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The study area consists of multiple large parcels north of Delta. Several potential erosional features/ conveyances were assessed and no indicators of OHWM were identified in any channels. Two wetland features approximately 9.92 acres (Wetland C) and 0.02 acre (Wetland F) in size were delineated on site. The larger wetland is supported by a series of wells, impoundments, excavated conveyances and headgates. This wetland is contained within a depressional area and does not contribute hydrology to other channels or jurisdictional features. The small wetland is an artificially created feature supported by runoff from irrigated lawns to the northwest. Hydrology is contained within the small depressional area and any potential downstream connection is completely severed by Brush Wellman Road.

If any aquatic features on site were to receive sufficient hydrology to flow off site, that flow would discharge into the Sevier River, the main channel in the larger drainage area. The Sevier River terminates in the Sevier Lake dry lake bed. Sevier Lake is a remnant of ancient glacial Lake Bonneville and is located in a closed basin at the terminus of the Sevier River. Water from the Sevier River is almost entirely diverted for irrigation purposed throughout the upstream length of the river. Therefore, Sevier Lake has been virtually dry throughout recorded history except for brief periods of unusually high precipitation and runoff in 1913, 1922, mid 1980s and 2011. The lake is not navigable and cannot be tied to interstate or foreign commerce associated with navigation due to absence of water. Sevier Lake does not consistently or regularly receive water such that physical indicators of an ordinary high water mark could develop. The nearest TNWs, Mona Reservoir, Sevier Bridge Reservoir (Yuba Lake), and Piute Reservoir are approximately 45 miles northeast, 30 miles east and 83 miles southeast of the study area, respectively. Mona reservoir is located in a different watershed and both Piute and Sevier Bridge (Yuba Lake) Reservoirs are located upstream of Sevier Lake. Sevier Lake is an intrastate, isolated feature with no interstate or foreign commerce connection.

The Corps has determined that Wetland C and Wetland F are intrastate isolated features with no apparent interstate or foreign commerce connection. Therefore, these features are not regulated by the Corps.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
