the consultant's December 4, 2017 field survey. The feature exhibits ordinary high water mark (OHWM) indicators such as evidence of recent hydrology (algal mats and mud cracks). The bed of the feature is six to ten feet wide and supports wetland vegetation. The banks are confined to the excavated width. The flow regime appears to be artificial and would be driven by overland flow and flow from adjacent canals, ephemeral drainages, and potentially influence from shallow groundwater inflow. If any flow occurs in this feature, it would terminate at mud flats that drain to the Sevier Lake. The Sevier Lake was previously determined to be an intrastate, isolated feature with no interstate or foreign commerce connection (see SPK-2009-00193; SPK-2009-00203; SPK-2010-00715; SPK-2013-00295; SPK-2017-00634), and is therefore non-jurisdictional due to the lack of downstream connection or other jurisdictional features. The nearest known USACE jurisdictional waterbody, Yuba Lake, is located approximately 50 miles upstream of these features.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
