- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A total of 0.03 acre of ditches were identified in the February 6, 2018, delineation report prepared by Stantec. NVD1-NVD4 are unvegetated roadside ditches that are approximately three feet wide and exhibit natural line impressed on the bank, shelving, changes in character of the soil, destruction of terrestrial vegetation, presence of litter and debris, leaf litter disturbed and washed away, scour, deposition, presence of bed and bank, and water staining indicators of an OHWM. The following aquatic resources are generally not regulated by the Corps of Engineers as they are manmade ditches created solely in uplands and draining only uplands that do not carry a relatively permanent flow of water. NVD1-NVD4 – ditches (including roadside ditches) excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
