C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- B. ADDITIONAL COMMENTS TO SUPPORT JD: The Smith Ranch Wetlands H, B and I (1.11 acres) are physically isolated and surrounded by upland, with no surface connection or hydrologic outlets to a jurisdictional WUS. The wetlands may have natural groundwater supplied hydrology, but are also significantly enhanced by the Buffalo Mountain Ditch lateral associated with a much larger wetland complex outside the project area (Wetland A). This wetland was previously determined to be isolated and non-jurisdictional (SPK-2017-00131). The easternmost edge of Wetlands H, B and I terminates on the Smith Ranch property. The Blue River lies to the east approximately 1,040 feet, flowing south to north. Between the easternmost edge of the wetland and the Blue River is Highway 9/Blue River Pkwy and a residential development. These wetlands also lie at least 850 feet west of the 100-year floodplain of the Blue River. Wetlands H, B and I are not considered adjancent to the Blue River.
