Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The 593-acre project site contains approximately 4.78 acres of palustrine emergent wetlands and 4,822 linear feet (3.05 acres) of ephemeral channel. Localized precipitation events and spring runoff are the hydrology sources for the channel and it only flows in these circumstances. The wetlands are supported by seeps that provide hydrology for a portion of the year and drain into the channel. The low volume of flow from the wetlands quickly percolates into the gravel and cobble substrate of the channel and does not flow off site.

These features are located within a closed-drainage basin in the arid western region of Utah. The channel displays a discontinuous ordinary high water mark as it drains in a generally southwest direction, occasionally merging with other similar ephemeral channels and eventually flows into South Pine Wash, a named ephemeral channel on USGS topo maps. Approximately 17 straight-line miles southwest of the study area, all indicators of ordinary high water mark dissipate into a remnant dry lakebed. This point is approximately 46 miles from Yuba Lake, the nearest traditionally navigable water (TNW), which is not in the same watershed. The nearest downstream TNW is Great Salt Lake, approximately 54 miles north of the study area. The Corps has determined that the channel and wetlands within the study area are intrastate, isolated features with no apparent interstate or foreign commerce connection. Therefore, these features are not regulated under CWA Section 404.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The features identified in the study area have no physical, chemical or biological connection to traditionally navigable waters. An extreme flood event (100-year flood) could potentially flow approximately 32 miles northwest from where the channel and OHWM indicators disappear. In that case, all flow would be contained in another closed drainage basin in the Great Salt Lake Desert, with no connection to other waters.
