If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There are five tributaries (D1T1-D1T5) to Slaven Creek (D1) which are all ephemeral drainages receiving water from precipitation runoff or seasonal snowmelt. D1 is an approximately 37,634.92-foot long intermittent stream with seven wetlands lying within or adjacent to the ordinary high water mark (OHWM). D1 OHWM terminates into vegetated upland swales approximately 7,000 feet from the mouth of Slaven Canyon (or 7 miles west of the Reese River). The upland swales then braid out into the alluvium with no indicators of OHWM, bed and bank, sediment sorting, or erosional features. These upland swale features terminate approximately 1.3 miles from the Reese River.

There are seven wetlands associated with D1, cumulatively totaling 6.67 acres, and all classified as palustrine emergent wetlands. These seven wetlands are all adjacent to Slaven Creek all having an unbroken surface or shallow subsurface connection to Slaven Creek (see attached map *Figure 9*). Wetland 1 is approximately 0.33 acre and lies upstream from D1T3 it is supported by a perennial spring feature which provides surface water for approximately 1600 feet before being lost to infiltration. Wetland 2 is approximately 0.27 acre and is located near the base of Slaven Canyon, downstream from Wetland 4. Wetland 4 is approximately 0.30 acre and lies upstream from Wetland 2. Wetland 5 is approximately 3.88 acres, and lies near the confluence of D1T2 and D1. Wetland 6 is 0.08 acre, and is located near Wetland 5 and the confluence of D1T2 and D1. Wetland 7 is approximately 1.67 acres, and is located

upstream from the confluence of D1T2 and D1. Wetland 8 is approximately 0.14 acre, and is located slightly upstream from Wetland 7. Wetlands 1 and 2 were delineated in the field. Wetlands 4-8 were identified during the desktop analysis and presence and boundaries of the wetlands were confirmed during the field visit. D1T1 is an ephemeral drainage approximately 3,086 feet long, and averages 4 feet wide. D1T2 is an ephemeral drainage approximately 8,438 feet long, and averages 6 feet wide. D1T3 is an ephemeral drainage approximately 17,390 feet long, and averages 5 feet wide. D1T4 is an ephemeral drainage approximately 9,430 feet long and averages 5 feet wide. D1T5 is an ephemeral drainage approximately 7,902 feet long, and averages 7 feet wide. All five ephemeral drainages receive all their waters from precipitation runoff or seasonal snowmelt.

D1 has no surface or shallow subsurface hydrologic or hydrogeological connectivity to the Reese or the Humboldt Rivers and thus has no connectivity with Rye Patch Reservoir, which is the closest Traditionally Navigable Water. D1 has no interstate or foreign commerce connection. Based on this information all of the aquatic resources identified are intrastate, isolated non-navigable waters and are not considered waters of the United States.
