C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Provide data and rationale indicating that tributary is perennial: The drainage area of channel C2(a-h) is on a north facing slope and is large enough that perennial flow could reasonably be assumed. Site visits late in the growing season and during the dry season of a drought year confirmed presence of base flow. Aerial imagery appears to show flows in the channel at varying times of the year. A spring or seep area appears to be present up gradient and just outside the study area which may also support year-round flow in the channel. Much of the same applies for the small segment of channel C3 within the study area just before joining C2. McHenry Canyon has an even larger drainage area and multiple site visits confirmed perennial flow. Channel C2 flows southeast under an old rail grade, under US-40, and in to Jordanelle Reservoir, approximately 2,750 feet from where it flows off site.

Hydrology supporting channel C2 also directly supports these wetland features. Wetland W4a is located in a deep depression surrounded by roadway embankment and mine tailings. Hydrology comes from groundwater and from mine water control pipes. This wetland flows under US-40 through large culverts, providing hydrology for a short off-site perennial channel between the roadway embankment and Jordanelle Reservoir.

 - Other: (explain, if not covered above): The abandoned impoundment pond was excavated on a hillside and historically had water piped into it for mine-related uses. The pond now collects ground and surface water in the bottom and shows no signs of overflowing into an abandoned outlet pipe near the top of the berm. Approximately 25 feet of elevation separate the OHWM and the outlet pipe. This pond is a man-made depressional feature that was excavated in uplands and is not jurisdictional.

Wetlands W5a and W5b are located near the mine portal and are the result of a break in the mine water control structure in the hillside. Water flows from the break into abandoned concrete foundations of the old mine entrance and rail car tracks. These wetlands have established in man-made depressional features that were excavated in uplands and are not jurisdictional.

Wetland W4b is a non-jurisdictional wetland feature supported solely by a break in the 12-inch pipe that carries water from the mine portal to W4a. Water spilling from the break flows down a moderately steep dirt access road creating the wetland area in an otherwise upland area, and is an obvious result of the broken pipe.
