C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Hansen wetland is physically isolated and surrounded by upland, with no surface connection or hydrologic outlets to a jurisdictional WUS. During snowmelt this wetland drains eastward toward a large drainage that flows toward Brush Creek, at times shunted into road-side ditches, approximatley 3,600 linear feet and 475 feet in elevation down-gradient. This drainage has possible marginal discontinuous OHWM physical indicators in the upper portion of the feature, but becomes less discernable further down-gradient. At approximately 1,100 feet from Brush Creek all indications of erosional features fade as any flows from snowmelt dissipate into the ground (39.256916, -106.891652). Between the terminus of this erosional feature and Brush Creek is a road and a large ranch operation. This wetland is not adjacent to any jurisdictional tributary.

There is no information available to show that the aquatic resource in review 1) is or could be used by interstate or foreign travlers for recreational or other purposes, 2) produces fish or shellfish which are or could be taken and sold in interstate or foreign commerce, or 3) is or could be used for industrial purposes by industries in the interstate commerce.
