- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Eight seasonal wetlands, identified as WF-05, WF-06, WF-07, WF-08, WF-09, WF-10, WF-11, and WF-12 occur within the review area. These wetlands are located adjacent to a constructed berm constructed as part of the Old Durham Wood recycling and processing facility. The berm was constructed by the property owner between August 11, 1998, and June 3, 2003. Prior to that time, there are no wetlands that can be identified on the 1947, 1951, or 1969 aerial photographs. In addition, the aquatic resources within the review area are not included in the National Hydrography Dataset or the National Wetland Inventory. The soils within the review area as identified in the Natural Resource Conservation Service Soil Survey are classified as Doemill-Jokerst Complex, 0 to 3 percent slopes and Doemill-Jokerst Complex, 3 to 8 percent slopes and are considered somewhat poorly drained. slope of a hill and would not be anticipated to occur, as the soil is above lava cap and seep wetlands do not generally occur in this area. The wetlands occur within a depression adjacent to the berm and there is a natural berm between the wetlands on-site and Hamlin Slough to the southeast and the unnamed ephemeral drainage to the north west of the review area. Therefore, due to the topography of the review area and vicinity these wetlands typically pond during the winter and spring months and the water evaporates as temperatures rise during the summer months. The hydrology of these wetlands is solely a result of seasonal precipitation. The aquatic resources on site do not flow or connect to waters of the U.S. and are therefore isolated and would not be regulated pursuant to the decision in *Solid Waste Agency of Northern Cook County v. U.S. Army Corps of Engineers*, 531 U.S. 159.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
