C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Channel 1 and 2 were previously coordinated with EPA for isolation on December 19, 2017. Channel 3 is an ephemeral stream approximately 754 feet long and 2 feet wide within the project area. Channel 3 drains off the project site through a culvert under North Virginia Street then continues for approximately 224 feet before converging with Channel 4. Channel 4 is an ephemeral stream approximately 147 feet long and 2.5 feet wide within the project area. Channel 4 drains off the project site through a culvert under North Virginia Street and continues to flow toward Swan Lake approximately four miles from the project site. Channels 3 and 4 have indicators of an ordinary high water mark within the project site and once combined drain toward Swan Lake. None of these ephemeral streams are identified on NWI or NHD maps. A defined channel is lost prior to reaching the Swan Lake for all four ephemeral streams. Swan Lake has previously been determined to be an isolated playa within a hydrologically closed basin with no connections to interstate commerce or a traditionally navigable water.
