ephemeral in nature. Secondly, based on the attached historical photos, it appears this feature was excavated wholly in, and drains only uplands. Furthermore, this feature does not carry a relatively permanent flow of water. Section 328.3: Definitions, states that we generally do not consider the following to be "Waters of the United States." (a) Non-tidal drainage and irrigation ditches excavated on dry land. Additionally, the June 5, 2007, Clean Water Act Jurisdiction Following the U.S. Supreme Court's Decision in *Rapanos v. United States & Carabell v. United States* memorandum to EPA regions and U.S. Army Corps of Engineers districts specifically states, "The agencies generally will not assert jurisdiction over the following features: 1) Swales or erosional features (e.g., gullies, small washes characterized by low volume, infrequent, or short duration flow), and 2) Ditches (including roadside ditches) excavated wholly in and draining only uplands, and that do not carry a relatively permanent flow of water."

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: DD1 conveys irrigation run-off from residential developments east of Brady Lane to the seasonal wetland labeled as SW2. Based on historic aerials, DD1 was constructed concurrent with the adjacent residential development to the east and was excavated in uplands and drains only uplands.**
