C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

generally does not consider these types of aquatic resources waters of the U.S. except on a case-by-case basis. In this case, the South Lateral Ditch and the Lone Cone Ditch are irrigation ditches constructed entirely in uplands, with all flows terminating in uplands and no surface flows from these ditches reach a water of the U.S. All other wetlands present within the study area would revert to uplands if the irrigation ceased. A man-made depression is also located within the study area. The depression does not have an outlet. As such, the South Lateral Ditch, the Lone Cone Ditch, wetlands associated with the ditch and the man-made depression are not considered jurisdictional.

Other information (please specify): Downstream of the study area, the South Lateral Ditch heads westerly for approximately 1 mile, then zig-zags north and west for approximately one more mile to its terminus. At its terminus (Latitude 38.130898°, Longitude - 108.315186°), the South Lateral Ditch irrigates lands through a system of above ground pipes that spread the water over approximately 35 acres. There is no surface connection to named tributaries or other relatively permanent waters (e.g., other ditches). Additionally, a 3/2/218 email from Mark Ragsdale, San Miguel River Water Commissioner, stated that the South Lateral Ditch and its lateral, the Lone Cone Ditch “dead ends on agricultural property” and that the water is used to “extinction”. The study area also includes irrigated wetlands associated with a collection pond. These wetlands are fed by agricultural irrigation practices and are surrounded by uplands. A man-made depression was constructed adjacent to the lateral ditch to act as a settling basin but historically does not receive water.
