2. Non-regulated waters/wetlands (check if applicable):3

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The proposed project site is made up of four parcels and each parcel contains a single man-made, ground water detention basin. The project site contains four basins, each approximately 2-acres in size, which are surrounded by a berm approximately 8-feet high and 35 feet wide at the base. The berms rise above the surrounding agricultural land, which can be seen in the site photographs and required regular maintenance to prevent leaks and deterioration. Their purpose was to act as a heat sink to regulate local temperatures to protect the crops, (wine grapes). Historically, a pump was used to fill the basins with ground water, and there are no culverts or other hydrologic connections into or out of the basins. The pumping of groundwater into the basins has recently ceased, and current hydrology is solely from precipitation. Due to clearing, burning, and agricultural activities, no vegetation exists within the basin, and therefore normal circumstances are not present. All basins contained hydric soils and indicators of hydrology. Because normal circumstances do not exist and the vegetation that previously existed could not be determined, per the 1987 Corps of Engineers Wetland Delineation Manual and 2008 Arid West Regional Supplement, based on the presence of hydric soils and indicators of hydrology, these basins are considered wetlands. Based on current and historic aerial photographs, we have determined the detention basins were constructed in uplands and are isolated, intrastate waters with no interstate or foreign commerce connection and therefore are not jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

The berms rise above the surrounding agricultural land, which can be seen in the site photographs and required regular maintenance to prevent leaks and deterioration. Their purpose was to act as a heat sink to regulate local temperatures to protect the crops, (wine grapes). Historically, a pump was used to fill the basins with ground water, and there are no culverts or other hydrologic connections into or out of the basins. The pumping of groundwater into the basins has recently ceased, and current hydrology is solely from precipitation. Due to clearing, burning, and agricultural activities, no vegetation exists within the basin, and therefore normal circumstances are not present. All basins contained hydric soils and indicators of hydrology. Because normal circumstances do not exist and the vegetation that previously existed could not be determined, per the 1987 Corps of Engineers Wetland Delineation Manual and 2008 Arid West Regional Supplement, based on the presence of hydric soils and indicators of hydrology, these basins are considered wetlands. Based on current and historic aerial photographs, we have determined the detention basins were constructed in uplands and are isolated, intrastate waters with no interstate or foreign commerce connection and therefore are not jurisdictional.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. The determination whether a significant nexus exists is determined in Section III.C below.

C. SIGNIFICANT NEXUS DETERMINATION

3.

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:




Figure 1 – Site Vicinity Map

Violich Farms Sutter Home Study Area







