This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD: The ~901-acre property in question contains approximately 19-ephemeral stream features, totaling 14.63 acres in size, which flow only in direct response to precipitation, and do not generally contain water except during and after significant storm events. Flow direction for each of these features appear to have been manipulated for drainage so that surface flows are captured and expedited away from the airstrip. Washes 001, 001A, 002S, and 007A each flow into Wash 015. Wash 012A flows into Wash 012

B. ADDITIONAL COMMENTS TO SUPPORT JD: The ~901-acre property in question contains approximately 19-ephemeral stream features, totaling 14.63 acres in size, which flow only in direct response to precipitation, and do not generally contain water except during and after significant storm events. Flow direction for each of these features appear to have been manipulated for drainage so that surface flows are captured and expedited away from the airstrip. Washes 001, 001A, 002S, and 007A each flow into Wash 015. Wash 012A flows into Wash 012. The OHWMs of Washes 002N, 003N, 003S, 004, 005N, 005S, 006, 007, 010, 011, 012, 013, 014, 015 and any associated confined surface connection are broken due to fill and grading. A man-made impoundment with wetland characteristics (0.25-acre large) exists northeast of the intersection of Ellsworth Avenue and O'Bannon Road and has no outlet. The closest Geographic Names Information System waterway, Las Vegas Wash, is approximately 5-miles to the south. There is no surface connection to a Traditional Navigable Water (TNW), no evidence of a subsurface connection, and no nexus to interstate commerce. The closest TNW is Lake Mead, which is approximately 12.5-miles to the south-southeast.
